

# Request for information under the Freedom of Information Act - 2024.033 Released – 24 April 2024

Thank you for your email dated 16 April 2024 requesting information regarding job titles and responsibilities.

Please find detailed below a summary of your original request together with our response.

## Original request:

It is trust policy not to release the names of staff below executive director level as this constitutes personal information. Therefore staff names are exempt under Section 40(2) in conjunction with Section 40(3A)(a) of the Freedom of Information Act 2000 which relates to 'Personal Information'.

An excerpt of the relevant Freedom of Information legislation can be found below:

### Section 40 – Personal information

- (2) Any information to which a request for information relates is also exempt information if—
- (a) it constitutes personal data which does not fall within subsection (1), and
- (b) either the first, second or third condition below is satisfied.
- (3A) The first condition is that the disclosure of the information to a member of the public otherwise than under this Act
  - (a) would contravene any of the data protection principles, or
  - would do so if the exemptions in section 24(1) of the Data Protection Act 2018 (b) (manual unstructured data held by public authorities) were disregarded.
